REVISED REQUEST FOR PROPOSALS (RFP)

Digitization and Operation of Parking Sites in Islamabad

The Directorate of Municipal Administration (DMA), Metropolitan Corporation Islamabad (MCI), invites sealed proposals from well-reputed and experienced firms/consortiums for the Digitization, Management, and Operation of Designated Parking Sites in Islamabad under a Public-Private Partnership Model. The objective is to implement a Smart Parking System to improve efficiency, transparency, and revenue collection.

The contract will be awarded on a Revenue Sharing Basis as per defined Terms of Reference (TORs). The procurement shall be carried out under the Single Stage – Two Envelope Procedure in accordance with Rule 36(b) of the Public Procurement Rules, 2004.

- Earnest money amounting to Rs. 10.000 million (Ten Million) (refundable) for each cluster must be submitted with the technical proposal in the form of Call Deposit Receipt (CDR) in favor of DDO, DMA, MCI. Proposals without bid security shall be rejected as non-responsive.
- The RFP will be evaluated under PPRA Rule 2004, and only technically qualified firms will be invited for financial bid opening.
- The prospective bidders are required to submit their Bids online through E-PADS at http://www.eprocure.gov.pk before closing date. Original Bids in accordance with the provisions of Section- 36(b) of Public Procurement Rules-2004 and terms & conditions defined in the tender documents must be submitted in the office of Director DMA, MCI on or before 30-07-2025 at 11:00am.
- 4. The proposals must be submitted in separate sealed envelopes clearly marked as "Technical Proposal" and "Financial Proposal", both enclosed in one outer sealed envelope.
- 5. Incomplete, conditional, or late submissions shall not be entertained.
- 6. MCI reserves the right to accept or reject any or all proposals under Rule 33 of PPRA Rules 2004.
